

Greenland opens up from the 15th June to residents and citizens:

Denmark

Faroe Islands


Norway

Iceland

Germany

By 31st August: DK decision about Sweden and Finland, and other lands



Conditions for entry during Phase 1

- In DK: R Factor under 1 and under 5% of population infected
- 600 pax per week, the 5th day test in Greenland is free
- Cancel for Any Reason insurance recommended!



Phase 2 (min. 3 weeks)

- In DK: R Factor under 0,7 and under 2% of population infected
- 1200 pax per week
- Same quarantine requirements as phase 1 apply.

Phase 3

- In DK: R Factor under 0,5 and under 1% of population infected
- No pax limit
- No quarantine requirements





Iceland route open!

- Confirmed only recently
- Unsure how pax limit entry will be divided between DK and IS
- Iceland Air flights will likely start again to Nuuk from July
- Air Greenland flights from Keflavik scaled down






Cruise ship

Politicians still discussing whether to allow cruise

BUT if allowed, NOT included in the 600 pax

Contactless cruise ship activities delivered to the Corona Advisory Board






What is quarantine?

- No contact with locals except when undergoing transportation to 'final destination'
- Grocery shopping should be restricted. Meals served in hotel rooms, takeaway delivery allowed
- No public transport or taxis
- Limit contact with those you live with. Stay in private accommodation or hotels
- Wilderness walks allowed even multi day ones!


Wilderness quarantine

- You may hike into the wilderness for 5+ days
- It is ok to come back to a major town on 5th day or at a later date, but the test must be prebooked
- Quarantine must be held for 14 days if not retested with negative results
- You may quarantine with your group, but guide must be part of original group.









Transportation vs Tourism

- You may use the normal means of transportation to get to your final destination.
- You may follow your itinerary if there is a stopover
- You may travel to your final destination to get retested, provided you can show the first negative test when getting transported
- You may NOT charter a boat for a tour



Other FAQs

- May I charter transportation to get to a remote accommodation?
 Probably
- May I charter a boat or use public transportation to get tested on the
 5th day? Awaiting response
- May I kayak into the wilderness for 9 days and then get tested later?
- What if the tourist does get sick? Contact hospital
